# Information requirements for contracts in electronic commerce

In the case of contracts in electronic commerce, the entrepreneur must the customer (whether entrepreneur or consumer) in accordance with § 312i BGB in conjunction with. Art. 246c EGBGB inform:

- 1. about the individual technical steps that lead to the conclusion of a contract lead to the conclusion of the contract;
- 2. whether the text of the contract is stored after the conclusion of the contract by the entrepreneur after the conclusion of the contract and whether it is accessible to the customer;
- 3. about how he can use the technical means provided in accordance with § 312i para. 1 sentence 1 No. 1 BGB to correct input errors before they occur. technical means available to the customer to identify and correct input errors and correct them before submitting the contractual declaration;
- about the languages available for the conclusion of the contract and
- 5. about all relevant codes of conduct to which the entrepreneur the entrepreneur is subject to, as well as about the possibility of electronic access to these codes.

These individual requirements, concerning the contractual relationship with us, we may explain to you as follows:

### To 1.

At the end of your registration you have to confirm that you accept the under "Terms and Conditions" on our website:

A contract is concluded - provided that you are the highest bidder - only by pressing "My bid".

Any other action in the browser, for example clicking the link "Back to object", cancels the bidding process.

If you are the highest bidder at the end of the auction, the purchase contract is between you and the seller.

You will receive a message by e-mail with all further information about shipping and payment procedure. You can pay the invoice amount by bank transfer. If you want to pick up the object, you can inform us. You have the choice to pick up the object in Wiesbaden by appointment. to pick up. If you pick up the object, you can also pay the invoice in cash.

## to 2:

The contract text is not stored. You have the possibility to copy your bidding data and print it out for your records. The current status of your bids during the term of the auction under "My account" and there under "Auctions" at "Bids active".

### to 3:

If you want to change your displayed data (username, billing address, i.e. your master data), you can do this at any time under "My account". at any time.

## to 5:

The provider has not subjected itself to any code. There are special information obligations in electronic commerce towards consumers according to § 312j Abs. 2 BGB i.V.m. Art. 246a § 1 para. 1 S. 1 No. 1, 4, 5, 11, 12 EGBGB (Introductory Act to the German Civil Code), which we meet by the following explanations:

## offered goods / conclusion of the contract

Possible defects have been taken into account in the price.

The objects offered by KunstKontor on the Internet or in any other way represent represent offers for sale. The bidder makes a binding bid.
